- 1. Nominations are called by me from Corporate Members for posts in the Council of EGSL for the session 2025/2026, as per the details which follow. Specimen Nomination Paper is attached to this notice. Nominations should be conveyed either by Registered post to the address, Engineers' Guild of Sri Lanka, Room 14, The Professional Center, No. 275/75, Prof. Stanley Wijesundara Mawatha, Colombo 7. or via email to the address registrar.egsl@gmail.com so that they are received by this office on or before 4.00 pm on 14th June 2025. Nominations received thereafter will be invalid.
- 2. A candidate may seek election for one post only at the election. Each candidate shall be nominated by four (4) Corporate Members. No candidate shall submit nominations for more than one post. No candidate who has submitted one nomination paper shall submit another nomination paper for another post, unless and until previous nomination paper is withdrawn in writing to the Registrar, before the time fixed for closing of nominations. The Nomination Paper shall be submitted with the written consent of the Candidate in the prescribed format.
- **3.** The post of President (one vacancy) shall be elected by the Corporate Members from among Corporate Members who have served the Council **at least five sessions**. The term of office shall be one (1) session and shall be eligible for re-election.
- **4.** The posts of Vice President, Honorary Secretary, Honorary Treasurer, Honorary Assistant Secretary, Honorary Assistant Treasurer are only one vacancy for each post and shall be elected by the Corporate Members from among Corporate Members. who have been on the roll for **more than one (1) year**, and their term of office is one session.
- 5. There are nine (9) vacancies for Council Members, and they shall be elected by the Corporate Members from among Corporate Members who have been on the roll for more than one (1) year, and their term of office is one session.
- **6.** In the case where the number of nominations received is more than the number of vacancies, elections will be held at the Annual General Meeting by secret ballot by those present with a simple majority by the Corporate Members.
- **7.** If there are insufficient number of nominations for vacancies, the names for such posts can be proposed and seconded by Corporate Members present at the AGM. The election will be by secret ballot by Corporate Members present with a simple majority
- **8.** Elections to Council are in accordance with By-laws (Approved at the SGM held on 13th January 2020 and amended at the SGM held on 23rd February 2023 and amended at the AGM held on 21st August 2024)
